High School Exhibit and Competition

Rules of Entry:

- Submit entry form and entry fee \$10 online at **ArtFestFortMyers.com/au20**.
- All public, private, and homeschooled high school students in Lee County are encouraged to enter.
- **ONE** entry per student is allowed in the Art Under 20 High School Exhibit and competition.
- All artwork submitted must be original and produced exclusively by the student submitting the artwork. **No parent-assisted or teacher-assisted artwork is allowed.**
- Categories: Digital, Drawing, Painting, Photography, 3-Dimensional, Mixed Media, Recycle Materials
- All two-dimensional works must be **FRAMED** and must be ready to hang. This means there must be a **HANGING WIRE** on the back, which will support the weight of the work. A hook will be provided by ArtFest Fort Myers to secure the work to the display wall. **Work without a hanging wire will not be accepted and no refund will be issued.**
- Label all work with student's name and school name (on the back or inside). **If there is no name on the artwork when it enters the Art Under 20 tent it will not be accepted.**
- All artwork must be secure with no loose, unattached, or hanging components.
- The criteria for judging will be: originality, creativity, craftsmanship, technique, and execution.
- All art will be judged on Friday, February 2 and ribbons will be installed on Saturday, February 3. Cash awards totaling \$10,000 will be awarded. The decision of the judges is final.
- Release and acknowledgment forms (one per student) **must be received by ArtFest Fort Myers no later than December 8, 2023**, and signed by the student & the student's parent or guardian.
- A confirmation email will be sent to the email address listed on the entry form, acknowledging receipt of your entry form. If you do not receive an email confirmation by January 9, 2024, you are not entered into the Art Under 20 High School Exhibit and Competition and will not be able to display your art in the Art Under 20 tent. **Entry forms are not transferable between students.**
- ArtFest Fort Myers will take great care with each piece of art; however, they cannot be responsible for damage or theft while the art is displayed. Overall festival security will be provided overnight and while the event is open, during the day.
- Pick up of the artwork will be Sunday, February 4, between 3:00pm and 5:00pm. Teachers or students with a picture I.D. may collect their art. We request that a designated school person be present at 5:00p to collect all leftover work. **ArtFest Fort Myers shall not be responsible for artwork not collected by 5:00pm.**
- This is an outdoor event. **We encourage students to waterproof their artwork** as humidity can and will adversely affect unprotected work.
- Violation of any of the rules may result in the revoking of any award granted by Art Under 20.
- The Art Under 20 Tent is closed to the public at 5:00pm Friday and Saturday.
- **Artwork must be delivered on your school's scheduled day, either Thursday, February 1 or Friday, February 2 between 1:00pm -4:00pm to Art Under 20 area.** ArtFest Fort Myers is located on Edwards Drive, along the riverfront, in downtown Fort Myers. Art Under 20 is located at the intersection of Heitman Street and Edwards Drive. Access from entrance at Bay Street and Heitman Street.
